



## **COVID-19 in St. Tammany**

### **Cases**


### As of June 16, 2020:

- 5<sup>th</sup> highest number of positive cases in Louisiana





# COVID-19 in St. Tammany Mortality

#### St. Tammany Daily Increase in COVID-19 Deaths







## **Unemployment Insurance Claims**

- Following the highest number of initial claims filed during the week ending on April 4, the number of initial claims per week has continued to decline from mid-April through late May.
- According to data from the Louisiana Workforce Commission, St. Tammany's labor force contracted from 118,851 in April 2019 to 107,599 in April 2020, a difference of 11,252.
- This could be because many workers who lost their jobs during the pandemic-induced economic downturn are not actively looking for employment and are therefore no longer counted as "unemployed;" they have left the labor force.








## **Unemployment Insurance Claims**

- As demonstrated on the previous page, the number of weekly initial claims has continued to decline, which has led to a flatter curve for the number of total claims filed in St. Tammany.
- **38,301** total initial unemployment insurance claims means that **more than 30%** of the workforce has been unemployed at some point since the stay-athome order began.
- St. Tammany's total number of initial claims is the **4**<sup>th</sup> **highest** in the state.
- LWC reported that St. Tammany's unemployment rate was 15.0% in April, slightly higher than the Louisiana's rate of 14.5% and lower than the Greater New Orleans rate of 18.8%.





## **Declaration of Recession**

On June 8, the National Bureau of Economic Research officially declared that the United States economy is in a **recession**.

In Q1 2020, US real GDP fell **-5.0%** from the previous quarter, the greatest drop in productivity since Q4 2008.


This decline reflects the response to the spread of COVID-19, as governments issued "stay-at-home" orders in March. This led to **rapid changes in demand**, as businesses and schools switched to remote work or canceled operations, and consumers canceled, restricted, or redirected their spending.





## **Changes in Small Business Revenue**


- Small business revenue began to take a dive around the time of the stay-athome order, and while making a slow recovery, has not yet returned to pre-COVID-19 levels.
- As of June 4, 2020, total small business revenue in St. Tammany decreased by 20.9% compared to January 2020.
- The lowest point was April 8, when revenue was at -51.1%.
- The steepest increase in small business revenue can be seen following the end of the statewide stay-at-home order.





## **Changes in Hours Worked at Small Businesses**

- As of June 7, 2020, total hours worked at small businesses in St. Tammany decreased by 18.3% compared to January 2020.
- The lowest point was around March 29-April 1, about one week following the stay-at-home order, during which hours worked at small businesses had plummeted to -53.1%.
- As more businesses begin to reopen and bring back staff, the number of hours worked at small businesses has begun to rise.






# Sales Tax Collections March 2019 vs. March 2020

The graphs below show the industries that demonstrated the greatest change in sales tax revenue, positive or negative, in March 2020 compared to March 2019.


Industries with the least change from March 2019 to March 2020, i.e. those with percent change closest to zero, include Administrative Support & Waste Management Services; Retail Trade; Transportation; and Information.

Note: Sales tax collections occur the month after the sales take place, with disbursements to jurisdictions occurring the month after that. For example, May sales, collected in June, will not be disbursed or reported until July.


## **Residential Travel Since Stay-at-Home Order**

The purpose of the community mobility report is to give insight into key questions:

- How have travel and mobility in St. Tammany been impacted by the pandemic?
- How well has St. Tammany adhered to the stayat-home order?
- Where are people going when they aren't going to work, going shopping, or doing leisure/entertainment activities?

#### **Definitions:**

- **Retail & Recreation**: places like restaurants, cafes, shopping centers, theme parks, museums, libraries, and movie theaters
- Grocery & Pharmacy: places like grocery markets, food warehouses, farmers markets, specialty food shops, drug stores, and pharmacies
- Parks: places like national parks, public beaches, marinas, dog parks, plazas, and public gardens
- Workplaces: places of work
- Residential: places of residence
- Negative percentages indicate reduction in travel
